## Official statement. Vöcklabruck, the 14-th of August 1945.

In the second part of May 1945. Lt. de Huszár commissioned by the C.I.C. of Vöcklabruck asked the Hungarian General Ankay-Anesini for the nomination of a Hungarian commission to investigate the status of officers and men belonging to the Hungarian divisions "Hungaria" and "Hunyadi" kept as prisoners of war in the camp of Mauerkirchen.

I myself as a liaison officer have taken part in the investigation immediately the day following the demand. The investigation settled the racial brake down of the above mentioned outfits as well as the reasons why officers and men joined this newly established combatteam.

The commission settled unanimously that all the officers and the men are of the very best Hungarian origin and all Hungarians indeed. All the officers and the men have volunteered for the divisions "Hunyadi" and "Hungaria", for instance those who have been older than 21 years; those of younger age have been compelled by the former government to join these unites in consequence of the missing of other possibilities of military instruction.

As a result of this survey the commission settled - excluding all doubts - that the divisions "Hunyadi" and "Hungaria" never made a part of the former SS troops. Although these Hungarian unites got their uniforms and armament from the German SS this measure concerning their outfit has been taken by the German high command for instance Himmler himself, who as the leader of the SS had taken over in the last months the command over all the parts of the German and even the cooperating armies /also Wehrmacht and Luftwaffe/, and managed them according to the stipulations of the SS. The adherents of the former mentioned Hungarian unites, as they came to Germany, have been attached to SS administration even without knowing it - and of course - without agreeing.

It has been settled by American side as a result of this investigation, that the above mentioned "Hungaria" and "Hunyadi" divisions are not treated in the same manner as the German SS and it has been officially notified to higher Hungarian headquarters, that the Hungarian army or Hungarian commands should take care of these 1.500 officers and men, they should be moved from the P.W.

camp of Mauerkirchen and the Hungarian staff at Vöcklabruck has got the right of free disposition of these military persons. In the followings Col. Temesváry — as the commander of the divisions — has taken the necessary measures to extend his command — authorised by the US army — also over these 1.500 officers and men.

It is not known and it could not be found the reason, why the officers and men of the above mentioned divisions have been put in the SS P.W. camp of Ebensee; but on the other hand a more detailed investigation showed, that besides the Hungarian soldiers there are also some hundred young Hungarian boys of the age between 16 and 18 belonging to the Hungarian youth association "Levente" and who are not to be considered as military persons.

The reports received by the staff indicate that in the P.W. camp Nr. 2. of Ebensee there are actually 2.200 Hungarians in a completely ruined state of health and in an even worse psyhic condition. Their commander is Maj. Várnay.

The commander of all foreigners who are suspected to have been SS troopers is Lt.Col. Ney, who is Volksdeutsch, born in Hungary. It seems probably that the Hungarian government has declared him as a war criminal or may declare him as one, when it will be evident, how many Hungarians of pure race have been lead astray by him and brought to the German SS. Besides the situation of the adherents of the "Hunyadi" and "Hungaria" divisions having had their own Hungarian commanders, service language and even military judges /only the equippment and administration was German/ there must be investigated also the case of officers and men belonging to the so called Ney-combatteam; all these men are treated - surely without the connaissance of the American authorities in a manner not digne to human beings.

The Hungarian nation has lost some hundred thousand men in this war, she needs therefore the efforts of all Hungarians, even those being far off. We ask therefore the American authorities to make it possible, that these persons could leave the camp of E-bensee as quick as possible and to enable them in this way to work where ever it may be and to give them the possibility to return to their country.
